Oversize/Overweight Permit Application

Issued Under Section 110 of the Highway Traffic Act

Provisions and Conditions

Permit is Not Valid:

- On any road or highway other than roads under the jurisdiction of the County of Oxford
- ii. On County of Oxford roads under construction or during load restriction periods as determined from time to time
- iii. On Saturday, Sundays and Statutory Holidays except Easter Monday
- iv. In congested traffic conditions when the overall width exceeds 3.05 metres (10 feet) or the overall length exceeds 24.5 metres (80 feet)
- v. From two (2) hours after sunset to two (2) hours before sunrise or at any other time when, due to insufficient light or unfavourable atmospheric condition, person and vehicles on the road are not clearly discernible at a distance of 150 metres or less.
- vi. After date of expiry.

Conditions:

- i. All conditions that are contained on the Ontario Ministry of Transportation Permit shall apply to this permit
- ii. When transporting a load in excess of 4.0 metres in width, 36.75 metres in length, or height of 4.87 metres, an escort is required based on the following requirements:
 - a. Private escort required for width from 4m to 4.59m 1 escort vehicle required
 - b. Private escort required for width from 4.6m to 4.99m 2 escort vehicles required
 - c. Private escort required for length from 36.76m to 45.74m or rear overhang greater than 4.65m 1 escort vehicle required
 - d. Private escort required for height from 4.87m or greater 1 escort vehicle/pole car required
 - e. Police escort vehicles are required for widths of 5.0m or greater and/or lengths of 45.75m or greater
- iii. A photocopy of this permit and an original of the Ontario Ministry of Transportation permit must be carried in the vehicle and produced on demand of a police officer or an officer for carrying out enforcement of the Highway Traffic Act
- iv. Permit must be applied for at least five (5) business days in advance of a planned move
- v. The applicant shall obtain and keep in force for the duration of this permit, automobile insurance under a standard Automobile Policy with limits no less than \$2 million in respect of each owned or leased licensed vehicle listed on the permit application. Proof of this coverage must be submitted to the County in the form of a Certificate of Insurance from the current policy term.
- vi. The permit is issued on the condition the permit holder accepts responsibility for any and all damage that may be caused to overhead wires, structures, roads, encroachments, or railway right-of-ways
- vii. Non-refundable permit fee as per the County Fees and Changes By-law payable upon application.
- viii. Permit is valid from date of issuance until date of expiry.
