Walk-in, first come/first serve, does not serve clients that exceed suggested income, house visits for housebound clients. Use the main/front entrance. Pick-up ONLY dates: Tue, April 30th, Wed, May 1st & Thu, May 2nd.

South Gate Centre, 191 Old Wellington Street, South, Woodstock Packages are available for pick-up & drop off completed tax returns available to the public, there WILL NOT be any tax volunteers on site. If you are wishing to make any inquiries regarding your taxes you must go to the Oxford County Administration Building, 21 Reeve St. Woodstock during the hours listed.

Eligibility Requirements

- Must be a simple tax return. If you have no income or if income is employment, pension, CPP, disability or employment insurance, social assistance, RRSP's, support payments, scholarships, fellowships, bursaries, grants, interest (under \$1000).
- In general, if you have an annual income (or less) of \$35,000 for one person up to \$52,500 for 5 persons (plus \$2,500 for each additional person). **Please note for up-to-date income requirement visit website link at bottom of page
- Individuals must complete and sign a consent form which gives permission for qualified volunteers to complete your personal tax return
- Individuals must complete and sign a consent form which gives permission to qualified volunteers to complete your personal tax return Individuals must provide all necessary receipts and information slips during the posted clinic dates for each location. Pick up of completed returns will be arranged by the volunteer.

Required documentation:

Proper identification

- All necessary Tax slips RC (62), T5007, T4, T4A, T4A (P), T4A (OAS), T4E, T3, T5 etc.
- Tax Return package and last year's Tax Return or Notice of Assessment
- All personal receipts for deductions you are claiming including Rent, Property Taxes, Charity receipts, Medical or Professional treatment receipts, RRSP contributions, Tuition fees, Daycare and Children's fitness receipts, Pharmacy Prescription receipts or summary, etc.

Returns not eligible:

Self-employment * employment expenses * business or rental income & expenses * capital gains or losses * bankruptcy in tax year * completing a return for a deceased person.
