Purpose and Effect

The County of Oxford is initiating a review of the Official Plan. The Planning Act, RSO 1990, requires that a municipality revise its Official Plan as required to ensure that it conforms with Provincial Plans, or does not conflict with them, has regard to matters of Provincial interest and is consistent with Provincial Policy Statements.

The Planning Act requires that Council hold a special meeting, open to the public, to discuss the revisions that may be required. This meeting will serve to formally initiate the current Official Plan review process, which is anticipated to be comprised of a number of phases. The geographic scope of the review includes all lands within the County of Oxford.

There have been a number of legislative and policy changes (e.g. Planning Act, 2020 Provincial Policy Statement etc.), which it is expected may require revisions to a number of the current Official Plan policies. A range of policy areas are anticipated to require review and potential updates as part of this process, including, but not necessary limited to, agriculture, natural heritage resources, community and urban design, housing, cultural resources, transportation and infrastructure, implementation measures etc.

Other areas for review may be identified through public and stakeholder input and further Planning staff review. The need for and specific nature of any proposed policy revisions will be determined as the County proceeds through the review process. Opportunities for public input on any proposed policy revisions that may arise from this review will be provided at future stages in the process.
